III. Description of the academic component

1. A Course Abstract

The syllabus of the academic component "Qualification Exam" (QE) is compiled in accordance with the education and professional program "International Information and Public Communications" for the preparation of masters in the specialty 291 "International Relations, Public Communications and Regional Studies". Effective training of students for such a form of control as a qualification exam requires the formation of a system of competencies acquired throughout the course of study, their updating and highlighting interdisciplinary connections, and is the task of this AC. The qualification exam is held in the third semester and aims to identify the knowledge, skills and abilities of the candidate in the normative AC, the study of which is provided for by the curriculum. The QE consists of three theoretical questions, each of which is estimated at 100 points.

Prerequisites: courses taken from the educational program. The QE program includes the following ACs: International Systems and Global Development, International Communications, Strategic Communications in a Security Context, Regional Security Analysis. Information and Psychological Operations in International Conflicts.

2. Goal and tasks of the academic component

The purpose of the certification is to determine the actual compliance of the training of higher education students with the goals and requirements of the education and professional program "International Information and Public Communications" of the second (Master's) level, to verify their knowledge, skills and abilities necessary for further professional activity. Higher

education students are provided with advisory assistance during preparation for QE, the generalization and systematization of the knowledge acquired during studies at the master's level of higher education are stimulated, information is provided about the peculiarities of the procedure for conducting, compiling certification exam tickets and the structure of the answers to them.

The main task of the QE is to determine the level of theoretical preparation of graduates for the goals and requirements of the education and professional program "International Information and Public Communications" of specialty 291 "International Relations, Public Communications and Regional Studies" of the second level of higher education, to test the abilities and skills of higher education students to solve complex specialized tasks and practical problems in the field of international relations, public communications and regional studies, foreign policy activities of states, international interactions between states, international organizations and non-state actors, which are characterized by complexity and uncertainty of conditions and involves the application of theories of social sciences and special scientific methods of researching problems of international relations in the process of professional activity, which involves the application of modern theories and methods.

- 10. Analyze the impact of artificial intelligence and big data on the effectiveness of information and psychological operations. What new risks does this create in international security?

IV. Evaluation Policy

Academic Integrity Policy

Any assistance to the student during the exam is prohibited. During the exam, it is prohibited for students to use additional information media, i.e., printed, handwritten, electronic, copying and/or distributing information during the preparation and passing of the qualifying exam in any form (including using electronic media). Identification of signs of academic dishonesty during the preparation and/or passing of the QE is grounds for its non-registration, regardless of the scale of plagiarism or deception. A student's appeal statement about his/her disagreement with the grade for the qualification exam given by the examination commission may be submitted by the student only on the day of the exam in writing to the head of the examination commission.

Deadlines and Rescheduling Policy.

If the student did not appear at the commission meeting to take the qualifying exam, then a note is made in the commission minutes that he/she was not certified due to failure to appear at the commission meeting. Students who did not pass the QE within the deadline approved for them have the right to re-certification during the next commission meeting within three years after graduation from the university, provided that there is a free licensed place in the chosen education and professional program.
