### III. Description of the academic component

#### 1. A Course Abstract

The educational component "Course work in International Relations and World Politics" covers the international relations study theoretical foundations, the interstate relations development modern trends, the prerequisites and factors for the world politics formation and the functioning of its components.

#### 2. Goal and tasks of the academic component

The aim of the course is to study the international relations essence, to get acquainted with the historical prerequisites for the interstate relations formation, to outline the world politics development modern features, to identify its implementation problems.

The main objectives of the course are:

- to analyze the theoretical aspects of the international relations essence and components;
- to determine the essence and give one's own assessment of the interstate relations development prerequisites and factors;
- to analyze modern problems of the implementation of different states foreign policy;
- to comprehend the processes, prospects and consequences, to argue one's own views on the world politics modern processes main contradictions;
- to prepare an information and analytical reference on the chosen topic.

#### 5. Guidelines for completing the course work

Topics of course work are developed by the teaching staff of the Department of International Relations and Regional Studies of Lesya Ukrainka Volyn National University in accordance with the subject area of the speciality 291 International Relations, Public Communications and Regional Studies, educational component International Relations and World Politics, taking into account previous individual proposals of students (if any). The topic of the course work may be amended or clarified if there are objective reasons.

The course work is written in English. The recommended length of the main text is 30-40 printed pages, including the list of references.

Structural components of the work:

- title page, which contains the name of the ministry, university and department where the course work was performed; title of the research topic; surname, name and patronymic of the student, year of study, specialty, educational and professional programme; surname, initials, academic title, position of the supervisor; city and year of performance;

- table of contents, which contains the names of all parts of the work and the numbers of their initial pages;
- introduction, which provides an overview of scientific research on the chosen topic, the degree of scientific development of the topic, the relevance, purpose and objectives of the research, the object and subject of the research, the theoretical basis of the research, a brief description of the structure of the course work, and approbation (if any);
- main body of the work, consisting of several charters. Each charter begins on a new page. The main charters should have bibliographic references to the used sources of literature. The first charter should present the theoretical aspects of the study, the conceptual and categorical apparatus on the chosen topic, a critical review of scientific works on the topic, etc. The second charter reveals the prerequisites and factors that influence the problem. The third charter contains a detailed analysis of the research subject and the author's own achievements;
- conclusions, which indicate the results of the student's scientific work. It is important that the conclusions give a complete and comprehensive answer to the tasks specified in the introduction;
- a list of references, which must include at least 35 sources, drawn up in accordance with the current requirements in accordance with DSTU 8302:2015, for different types of sources, arranged in alphabetical order, first the source in Cyrillic, then in Latin;
- appendices (if any), each appendix should be referenced in the text.

## **6. General requirements for the course work:**

The course work is to be written on A4 (210x297 mm) white paper. The main text is printed on one side of the sheet with an interval of 1.5 in Times New Roman font, font size - 14. Paragraph indentation is 1.25 mm. The text should be printed with the following margins: left – 30 mm, top, bottom – 20 mm, right – 10 mm. The text is presented, using the language of the scientific style.

The titles of the structural parts of the TABLE OF CONTENTS, INTRODUCTION, CHARTER, CONCLUSIONS, REFERENCES, APPENDICES are printed in capital letters in the centre of a new page at a distance of 3-4 intervals from the text. Subcharters headings should be printed in lowercase letters (except for the first capital letter) from the paragraph. Do not put a full stop at the end of the heading.

Pages, charters, subcharters, figures, tables are numbered in Arabic numerals without a number, such as 1, 2, 3, etc. The title page is included in the general page numbering, but the page number is not given; on the following pages, the number is given in the upper right corner of the page without a period at the end. The charter number is placed after the word CHARTER, no period is placed after the number, and then the charter heading is printed on a new line. Subcharters should be numbered consecutively within each charter: 1.1; 1.2, etc.

References are given in the text of the term paper in square brackets – [14, p. 20], where the first digit indicates the number of the source in the list of references, and the second – the page number. Format of quotation marks: «...» (for the text in Ukrainian), “...” (for the text in English). Be sure to distinguish between a hyphen (-) and a dash (–). The text is printed without hyphens.

Illustrations (drawings, graphs, charts, diagrams, photographs) should be placed immediately after the text where they are mentioned for the first time or on the next page, and they should be referenced in the text with the source. Illustrations should have a title that is placed directly below the image: Fig. 1. Title of the figure. A table should be placed immediately after the text in which it is first mentioned or on the next page. All tables should be referenced in the text. The word “Table” is indicated once to the right of the table. In the line below, type the name of the table, centre-aligned. Under the illustrative material and tables, it is indicated: \* Compiled by the author at: [] or \* Source: []. Appendices are indicated by consecutive capital letters of the English alphabet.



#### IV. Assessment policy

The educational process and control of its results is carried out in accordance with the Regulations on the current and final assessment of knowledge of higher education students of Lesya Ukrainka Volyn National University. The applicant for education has the right to receive a course work topic that meets his/her scientific interests, or may propose his/her own research topic.

The student is obliged to work conscientiously and systematically on the course work, regularly consult with the supervisor. When writing a course work, it is mandatory to comply with the principles of academic integrity. Plagiarism is unacceptable.

A student who has received an unsatisfactory grade for a course work may take into account all the advice and comments, make appropriate changes to the research and submit it for defense within the specified time limit.

#### V. Final control

No later than the established deadline, the student submits to the supervisor an edited and completed course work in accordance with current standards for its further review and admission to defense. The date and place of the defense are set according to the schedule of the examination session, and the supervisor must be included in the commission for the defense of the course work.

The public defense procedure consists of the following stages:

1) a report by the student on the content of the work, its relevance, purpose and objectives, object and subject of research, results obtained, etc. A presentation in Power Point is encouraged. The approximate duration of the report is 5 minutes. If the student has participated in conferences held in the current academic year, the presented published abstracts may be counted as a public presentation of the course work, provided that they are relevant to the topic of the course work;

2) discussion of the course work and scientific discussion: questions to the author and comments on the research paper, the author's answers, oral or written review by the supervisor;

3) announcement of the commission's decision on the research assessment. The decision on the grade for the completion and defense of the course work (on a 100-point scale) is made by the commission established by the Department of International Relations and Regional Studies based on the results of the public defense and discussion. The following assessment components are taken into account when making the decision:
